Overview

She has obtained Anton Piller orders and acted as independent supervising solicitor under such orders, which provide the right to search premises and seize evidence. She has also obtained Mareva orders that freeze defendant's assets prior to judgment, and Norwich orders that compel third parties to disclose information or documents for review by a claimant before initiating litigation.
